## **UPSC MAINS SYLLABUS DISCUSSION**

It is important to take note the syllabus for examination before beginning your preparation. As provided in the UPSC Notification:

"The main Examination is intended to assess the overall intellectual traits and depth of understanding of candidates rather than merely the range of their information and memory. The nature and standard of questions in the General Studies papers (Paper II to Paper V) will be such that a well-educated person will be able to answer them without any specialized study. The questions will be such as to test a candidate's general awareness of a variety of subjects, which will have relevance for a career in Civil Services. The questions are likely to test the candidate's basic understanding of all relevant issues, and ability to analyze, and take a view on conflicting socio-economic goals, objectives and demands. The candidates must give relevant, meaningful and succinct answers." - (UPSC-CSE Notification 2024)

Following is the paper-wise syllabus provided in the UPSC notification. We've done further breakup of the syllabus into standard subjects.

## PAPER 1 – ESSAY

There is no syllabus provided by the UPSC for Essay. However, the notification does mention the following:

"Essay: Candidates may be required to write essays on multiple topics. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression."

Indian Heritage and Culture, History and Geography of the World and Society

#### A] HISTORY

- 12] Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclone etc., geographical features and their location-changes in critical geographical features (including water-bodies and ice-caps) and in flora and fauna and the effects of such changes.

Governance, Constitution, Polity, Social Justice and International relations.

#### A] CONSTITUTION AND POLITY

- 1] Indian Constitution—historical underpinnings, evolution, features, amendments, significant provisions and basic structure.

## PAPER V - GENERAL STUDIES IV

Questions may utilise the case study approach to determine these aspects."

The following broad areas will be covered:

- 1] Ethics and Human Interface: Essence, determinants and consequences of Ethics in-human actions; dimensions of ethics; ethics in private and public relationships. Human Values lessons from the lives and teachings of great leaders, reformers and administrators; role of family society and educational institutions in inculcating values.
- 2] Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- 3] Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- **4] Emotional intelligence**-concepts, and their utilities and application in administration and governance.
- 5] Contributions of moral thinkers and philosophers from India and world.
- 6] Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance;

strengthening of ethical and moral values in governance; ethical issues in international relations and funding; corporate governance.

7] Probity in Governance: Concept of public service; Philosophical basis of governance and probity; Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery, Utilization of public funds, challenges of corruption.

Case Studies on above issues.

## MAKING BEST USE OF THIS BOOK

The final ranking in UPSC-CSE largely depends on the marks secured in UPSC Mains. Unfortunately, even at this stage, the preparation of students seems to lack a good strategy.

This book tries to address this issue. It does two things: First, it classifies the Official UPSC Syllabus into various subjects and second, the book divides the previous year questions (PYQs) into these various subjects and topics.

This classification brings all the PYQs under one subject/topic together. This gives a better insight into what UPSC expects from that particular subject and particular topic. It additionally also provides plenty of practice questions when we're studying the subject topic-by-topic.

Further, the book makes use of graphs to help us better understand the relative weightage of each subject/topic. These graphs also compare the last twelve years (2013-2024) weightage with last four years (2021-2024). This will help us understand the changing trend of UPSC in recent past.

Also note that each question is accompanied with a code which denotes, in given order, i) the year in which question was asked ii) question no. in official question paper iii) maximum marks and iv) word limit. For example [2021/Q2/10m/150w] denotes a 2<sup>nd</sup> question from year 2021, which was asked for 10 marks, to be written in 150 words.

Along with topic-wise questions, PART II of the book contains year-wise papers from 2013 onwards. This is provided so that you can have a look at entire question paper(s) at once.

So, do make use of all that the book provides and accordingly strategize your preparation. We really wish that your efforts do not go waste and you are able to systematically cover all of GS syllabus within stipulated time.

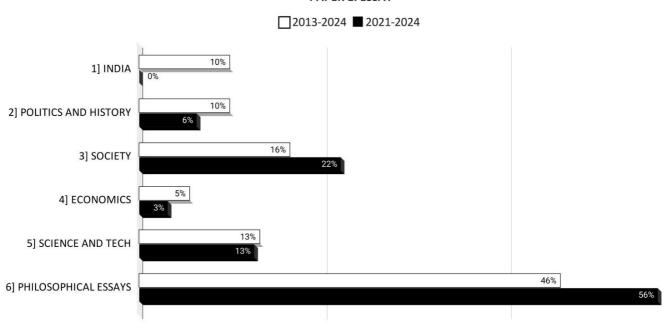
## PRACTICES ADOPTED IN THIS BOOK

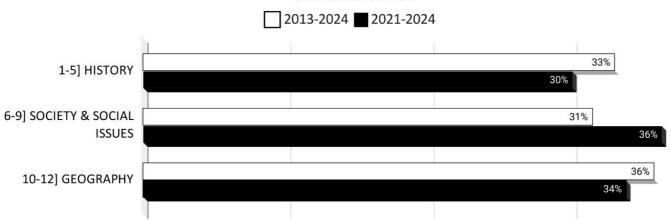

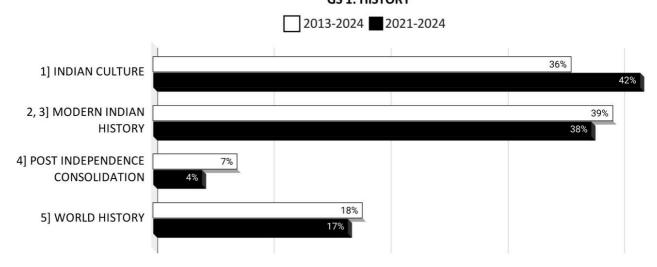

A Public Information Officer has received an application under RTI Act. Having gathered the information, the PIO discovers that the information pertains to some of the decisions taken by him, which were found to be not altogether right. There were other employees also who party to these decisions were. Disclosure of the information is likely to lead to disciplinary action with possibility punishment against him as well as some of his colleagues. Non-disclosure or part disclosure or camouflaged disclosure of information will result into lesser punishment or no punishment.

The PIO is otherwise an honest and conscientious person but this particular decision, on which the RTI application has been filed, turned out to be wrong. He comes to you for advice.

The following are some suggested options. Please evaluate the merits and demerits of each of the options:

- (i) The PIO could refer the matter to his superior officer and seek his advice and act strictly in accordance with the advice, even though he is not completely in agreement with the advice of the superior.
- (ii) The PIO could proceed on leave and leave the matter to be dealt by his successor in office or request for transfer of the application to another PIO.
- (iii) The PIO could weigh the consequences of disclosing the information truthfully, including the effect on his career, and reply in a manner that would not place him or his career in jeopardy, but at the same time a little

compromise can be made on the contents of the information.

(iv) The PIO could consult his other colleagues who are party to the decision and take action as per their advice.

You are working as an Executive Engineer in the construction cell of a Municipal Corporation and are presently in-charge of the construction of a flyover. There are two Junior Engineers under you who have the responsibility of day-to-day inspection of the site and are reporting to you, while you are finally reporting to the Chief Engineer who heads the cell.

While the construction is heading towards completion, the Junior Engineers have been regularly reporting that all construction is taking place as per design specifications. However, in one of your surprise inspections, you have noticed some serious deviations and lacunae which, in your opinion, are likely to affect the safety of the flyover. Rectification of these lacunae at this stage would require a substantial amount of demolition and rework which will cause a tangible loss to the contractor and will also delay completion. There is a lot of public pressure on the Corporation to get this construction completed because of heavy traffic congestion in the area. When you brought this matter to the notice of the Chief Engineer, he advised you that in his opinion it is not a very serious lapse and may be ignored. He advised for further expediting the project for completion in time. However, you are convinced that this was a serious matter which might affect public safety and should not be left unaddressed.

What will you do in such a situation? Some of the options are given below. Evaluate the merits and demerits of each of these options and finally suggest what course of action you would like to take, giving reasons.

- (i) Follow the advice of the Chief Engineer and go ahead.
- (ii) Make an exhaustive report of the situation bringing out all facts and analysis along with your own viewpoints stated clearly and seek for written orders from the chief Engineer.
- (iii) Call for explanation from the Junior Engineers and issue orders to the contractor for necessary correction within targeted time.

So far as child labour norms for hazardous industries like firecrackers industry are concerned, International Labour Organization (ILO) has set the minimum age as 18 years. In India, however, this age is 14 years.

The units in industrial clusters of firecrackers can be classified into registered and non-registered entities. One typical unit is household-based work. Though the law is clear on the use of child labour employment norms in registered/non-registered units, it does not include household-based works. Household-based work means children working under the supervision of their parents/relatives. To evade child labour norms, several units project themselves as household-based works but employ children from outside. Needless to say that employing children saves the costs for these units leading to higher profits to the owners.

On your visit to one of the units at Sivakasi, the owner takes you around the unit which has about 10-15 children below 14 years of age.

The owner tells you that in his household-based unit, the children are all his relatives. You notice that several children smirk, when the owner tells you this. On deeper enquiry, you figure out that neither the owner nor the children are able to satisfactorily establish their relationship with each other.
