MAKING BEST USE OF THIS BOOK

The final ranking in UPSC-CSE largely depends on the marks secured in UPSC Mains. Unfortunately, even at this stage, the preparation of students seems to lack a good strategy.

This book tries to address this issue. It does two things: First, it classifies the Official UPSC Syllabus into various subjects and second, the book divides the previous year questions (PYQs) into these various subjects and topics.

This classification brings all the PYQs under one subject/topic together. This gives a better insight into what UPSC expects from that particular subject and particular topic. It additionally also provides plenty of practice questions when we're studying the subject topic-by-topic.

Further, the book makes use of graphs to help us better understand the relative weightage of each subject/topic. These graphs also compare the last twelve years (2013-2025) weightage with last four years (2022-2025). This will help us understand the changing trend of UPSC in recent past.

Note that each question is accompanied with a code which denotes, in given order, i) the year in which question was asked ii) question no. in official question paper iii) maximum marks and iv) word limit. For example [2021/Q2/10m/150w] denotes a 2nd question from year 2021, which was asked for 10 marks, to be written in 150 words.

We would also like to stress that the exam pattern of UPSC-CSE changed drastically in 2013. Hence, the book contains questions only from 2013. Considering old question papers is not just unnecessary but also misleading. Further, thirteen years is a sufficient time to trace out a new pattern and provide plenty of practice questions.

Along with topic-wise questions, PART III of the book contains year-wise papers from 2013 onwards. This is provided so that you can have a look at entire question paper(s) at once.

So, do make use of all that the book provides and accordingly strategize your preparation. We really wish that your efforts do not go waste and you are able to systematically cover all of GS syllabus within stipulated time.

PART I UPSC MAINS SYLLABUS DISCUSSION

It is important to take note the syllabus for examination before beginning your preparation. **As provided in the UPSC Notification**:

"The main Examination is intended to assess the overall intellectual traits and depth of understanding of candidates rather than merely the range of their information and memory. The nature and standard of questions in the General Studies papers (Paper II to Paper V) will be such that a well-educated person will be able to answer them without any specialized study. The questions will be such as to test a candidate's general awareness of a variety of subjects, which will have relevance for a career in Civil Services. The questions are likely to test the candidate's basic understanding of all relevant issues, and ability to analyze, and take a view on conflicting socio-economic goals, objectives and demands. The candidates must give relevant, meaningful and succinct answers."

Following is the paper-wise syllabus provided in the UPSC notification. We've done further breakup of the syllabus into standard subjects.

PAPER I – ESSAY

There is no syllabus provided by the UPSC for Essay. However, the notification does mention the following:

"Essay: Candidates may be required to write essays on multiple topics. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression."

PAPER II - GENERAL STUDIES 1

Indian Heritage and Culture, History and Geography of the World and Society

A] HISTORY

- 1] Indian culture will cover the salient aspects of Art Forms, literature & Architecture from ancient to modern times.
- 2] Modern Indian history from about the middle of the eighteenth century until the present- significant events, personalities, issues.
- 3] The Freedom Struggle its various stages and important contributors/contributions from different parts of the country.
- 4] Post-independence consolidation and reorganization within the country.

12] Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclone etc., geographical features and their location-changes in critical geographical features (including waterbodies and ice-caps) and in flora and fauna and the effects of such changes.

Governance, Constitution, Polity, Social Justice and International relations.

- 1] Indian Constitution—historical underpinnings, evolution, features, amendments, significant provisions and basic structure.
- 2] Functions and responsibilities of the Union and the States, issues and challenges pertaining to the federal structure, devolution of powers and finances up to local levels and challenges therein.
- 3] Separation of powers between various organs dispute redressal mechanisms and institutions.
- 4] Comparison of the Indian constitutional scheme with that of other countries.

14] Conservation, environmental pollution and degradation, environmental impact assessment.

D] DISASTER MANAGEMENT

15] Disaster and disaster management.

E] INTERNAL SECURITY

- 16] Linkages between development and spread of extremism.
- 17] Role of external state and non-state actors in creating challenges to internal security.
- 18] Challenges to internal security through communication networks, role of media and social networking sites in internal security challenges, basics of cyber security; money-laundering and its prevention.
- 19] Security challenges and their management in border areas linkages of organized crime with terrorism.

PAPER V - GENERAL STUDIES IV

Ethics, integrity and aptitude.

"This paper will include questions to test the candidates' attitude and approach to issues relating to integrity, probity in public life and his problem-solving approach to various issues and conflicts faced by him in dealing with society. Questions may utilise the case study approach to determine these aspects."

The following broad areas will be covered:

- 1] Ethics and Human Interface: Essence, determinants and consequences of Ethics in-human actions; dimensions of ethics; ethics in private and public relationships. Human Values lessons from the lives and teachings of great leaders, reformers and administrators; role of family society and educational institutions in inculcating values.
- 2] Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- 3] Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- 4] Emotional intelligence-concepts, and their utilities and application in administration and governance.
- 5] Contributions of moral thinkers and philosophers from India and world.
- 6] Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values in governance; ethical issues in international relations and funding; corporate governance.
- 7] Probity in Governance: Concept of public service; Philosophical basis of governance and probity; Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery, Utilization of public funds, challenges of corruption.
